**AGREEMENT BETWEEN  
Dr. Bhatia Coaching Institute FMGE  
AND  
Jalal-Abad International University (JAIU), Kyrgyz Republic**

This Agreement (hereinafter referred to as the "Agreement") is entered into by and between:

- **Jalal-Abad International University (JAIU)**, located at 720904, Jalal-Abad, Kyrgyz Republic, represented by Acting Rector, **Mirsadyk Rakhimberdievich Narbaev**, acting in accordance with the University's Charter, hereinafter referred to as the "First Party."
- **Dr. Sushil Vijay**, hereinafter referred to as the "Second Party."

Both Parties, recognizing their mutual interests in advancing cooperation in the fields of medical education, healthcare, and related disciplines, and desirous of establishing formal, binding terms of collaboration, hereby agree as follows:

**Article 1.**

The Parties have established the following priority areas of cooperation:

- Implementation of joint projects in the field of medical education, medical science, and healthcare, based on specific programs and contracts concluded by the Parties for each joint project.
- Organization of joint educational events – symposia, conferences, seminars, workshops, schools, roundtables, and meetings.
- Exchange of scholars and specialists for delivering lectures and sharing advanced knowledge, for workshop and Exchange of our faculty for training.

This Memorandum does not impose any financial obligations on either Party.

**Article 2.**

The Parties agree that the positions outlined in Article 1 of this Memorandum will be implemented based on agreements concluded by the Parties for each joint project, as well as developed work plans/roadmaps and research programs containing information on joint activities, their organization, and financing conditions.

### Article 3.

All practical matters related to the organization of specific activities under Article 2 of this Memorandum must be agreed upon in writing and approved by the authorized representatives of the Parties.
