

CO-OPERATION AGREEMENT

Jalal-Abad City, Kyrgyz Republic

March 19, 2025

This Cooperation Agreement (hereinafter referred to as the "Agreement") is entered into by and between:

1. Institution "**Jalal-Abad International University**" (hereinafter referred to as "**JAIU**"), represented by its Rector, Mirsadyk Narbaev, acting pursuant to the Charter of **JAIU**, with its registered office at 24 Kurmanbek, Jalal-Abad, Kyrgyz Republic, on the one hand; and

2. LLC "**MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**" (hereinafter referred to as "**MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**"), represented by Nikunj Chachre, holder of an Indian passport with its registered office at Hyderabad on the other hand.

JAIU and **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.** are hereinafter collectively referred to as the "Parties" and individually as a "Party."

The Parties have agreed as follows:

1. SUBJECT MATTER OF THE AGREEMENT

1.1 **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.** shall undertake specific legal and administrative actions on behalf of **JAIU** to facilitate the recruitment of foreign nationals, primarily from India, for higher professional education in the field of General Medicine at **JAIU**. Such education shall be provided on a contractual basis under educational programs delivered in the English language.

2. RESPONSIBILITIES OF THE PARTIES

2.1 Obligations of **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**

MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD. shall:

2.1.1 Represent the interests of **JAIU** in various foreign jurisdictions, with a primary focus on India;

- 2.1.2 Recruit Indian students who have completed secondary or secondary specialized education for enrollment at **JAIU** on a contractual basis;
- 2.1.3 Coordinate and facilitate the administration of entrance examinations by the **JAIU** Admissions Committee in India, with provisions for online examinations in exceptional circumstances;
- 2.1.4 Provide assistance in identifying and recruiting prospective applicants for study at **JAIU**;
- 2.1.5 Where authorized by the **JAIU** Admissions Committee, designate a representative to conduct on-site entrance examinations;
- 2.1.6 Promote **JAIU** through advertising campaigns and career guidance initiatives in India, acting on behalf of **JAIU**;
- 2.1.7 Support the accreditation of **JAIU** in various countries and undertake promotional activities related to medical education in the Kyrgyz Republic, particularly with respect to international accreditation bodies;
- 2.1.8 Leverage its networks to attract foreign nationals to study at **JAIU**;
- 2.1.9 Advise **JAIU** applicants on entry and exit requirements for the Kyrgyz Republic;
- 2.1.10 Verify the authenticity of Indian students' passports and higher secondary school certificates;
- 2.1.11 Ensure the financial capacity of Indian students to fund their education, as guaranteed by **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**;
- 2.1.12 Submit the following documents to **JAIU** for processing entry formalities for Indian applicants:
- a) A copy of the applicant's passport;
 - b) A copy of the certificate of complete secondary education;
 - c) A payment order or equivalent document confirming the ability to pay for one year of study at **JAIU**;
- 2.1.13 Assist with the travel arrangements of foreign applicants to the Kyrgyz Republic, specifically to **JAIU**;
- 2.1.14 Provide the following documents to **JAIU** for student enrollment:
- a) A completed application form;
 - b) Evidence of an entry visa compliant with Kyrgyz Republic legislation;
 - c) The original certificate of complete secondary education, detailing subjects studied and grades obtained;
 - d) A medical certificate (Form 086) confirming the absence of contraindications to study, or arrangements for a medical examination upon arrival if unavailable;
 - e) The applicant's passport;
 - f) Four (4) photographs measuring 4x6 cm;
- 2.1.15 Facilitate the execution of study contracts between **JAIU** and foreign applicants;
- 2.1.16 Ensure that students obtain compulsory medical insurance in the Kyrgyz Republic, noting that such insurance is excluded from tuition fees.

2.2 Obligations of **JAIU**, **JAIU** shall:

2.2.1 Authorize **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.** to perform the legal actions outlined in this Agreement and issue necessary letters of authorization for sub-agents, as required;

2.2.2 Register foreign students and first-year applicants referred by **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**;

2.2.3 Provide foreign students and applicants equal access to **JAIU**'s reading rooms, libraries, sports facilities, and cultural centers alongside other students;

2.2.4 Allocate, to the extent possible, dormitory accommodations to foreign students for the duration of their studies at rates annually determined by **JAIU**;

2.2.5 Offer foreign student's opportunities for in-depth study of specific subjects for an additional fee;

2.2.6 Note that **JAIU** shall not provide scholarships, cover dormitory living expenses, or bear transportation or temporary accommodation costs for foreign students;

2.2.7 Assist foreign applicants and students with visa extensions and registration in the Kyrgyz Republic;

2.2.8 Refund excess tuition payments for an academic year, either to a designated bank account or in cash from **JAIU**'s cash desk, upon receipt of a written request or power of attorney from **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.**.

3. OTHER CONDITIONS

3.1 **JAIU** reserves the right to expel students for:

- a) Non-payment or delayed payment of tuition fees;
- b) Breach of **JAIU**'s internal regulations;
- c) Violation of residency laws of the Kyrgyz Republic; or
- d) Failure to meet contractual obligations.

3.2 The education of foreign students at **JAIU** shall adhere to an approved curriculum and programs aligned with the state educational standards and regulatory framework of the Kyrgyz Republic.

3.3 The Parties may invite representatives from each other's organizations to enhance collaboration, with financing for such visits subject to separate agreements. **JAIU** may also invite foreign teachers or volunteers as needed.

3.4 **MIECG MAKEMEDICO INTERNATIONAL EDUCATION PVT.LTD.** may assist in sourcing English-speaking instructors and providing teaching materials.

3.5 In the event of disputes, the Parties shall endeavor to resolve them amicably. Unresolved disputes shall be adjudicated in accordance with the laws of the Kyrgyz Republic.

3.6 This Agreement is executed in English in two (2) identical counterparts, each having equal legal force.

3.7 This Agreement shall take effect upon signing by both Parties and remain valid for one (1) year from the date of execution. The Parties may extend the Agreement by mutual consent upon its expiration.
