1. PURPOSE OF THE AGREEMENT

The purpose of this Agreement is to establish the terms and conditions under which medical students from the University will engage in practical training at the Hospital, providing them with clinical experience in a real-world healthcare environment.

2. DURATION OF THE AGREEMENT

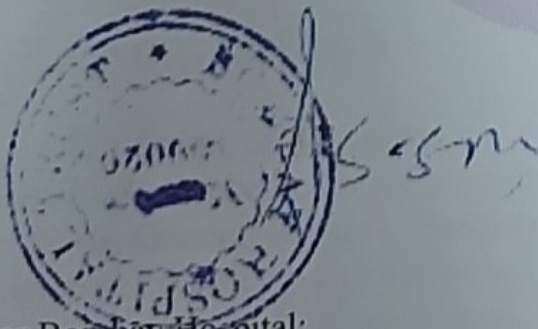
